3. PUBLIC FORUM


Don Maquin stated that he spoke with both candidates, and would like to know what were the plus and minus in the council's decision.

4. ADJOURNMENT


There being no further business to come before it, the Fernley City Council Special Meeting adjourned at 4:08 AM.
