**2. PRESENTATIONS**

**2.1. Presentation by Fernley Senior Municipal Court Judge Matheus regarding new laws from the last legislative session.**

Municipal Court Judge Matheus gave a presentation on the new traffic laws passed at the last legislative session.

**2.2. Presentation by the Nevada Aging and Disability Services Division to provide information on their various programs.**

CJ Johnson and Alissa Alonzo, Nevada Aging & Disability Services Division Adult Protective Services, gave a presentation on direct services to older adults, people with disabilities and family caregivers. The ADSD vision is that Nevadans, regardless of age or ability, will enjoy a meaningful life led with dignity and self-determination. ADSD services promote independence and respect for all. This includes, but is not limited to in-home service, caregiver support services and advocacy services. Services are offered through ADSD directly as well as in partnership with community organizations. Assisting vulnerable adults (age 18 to 59), in addition to persons 60 years and older who are abused, neglected, exploited, isolated, or abandoned by investing, providing, or arranging for services to alleviate and prevent further maltreatment while safeguarding civil liberties. Any person may report an incident of abuse if they have reasonable cause to believe abuse is occurring. Reports must be made to either Aging and Disability Services Division or any police department or sheriff's office. Protective services are provided if the individual is willing to accept these services.

**2.3. Presentation by the Alzheimer's Association to provide information on their organization.**

Sandy Severance, Community Engagement Manager for the Alzheimer's Association, gave a presentation on Caregiver Support groups. Caregiver support groups, conducted by trained facilitators, are a safe place for caregivers (family and friends) of persons with dementia to develop a support system; exchange practical information on caregiving challenges

and possible solutions; talk through issues and ways of coping; share feelings, needs and concerns; and learn about community resources. Support groups are free of charge for family and friends of people with dementia.

Bobbi Boger, Fernley Support Group facilitator, was also present.

They can come and pick up fliers and get information on resources available for seniors.
